SECTION 2: WAIVER OF LIABILITY, INDEMNIFICATION and HOLD HARMLESS AGREEMENT

1. In consideration of being allowed to participate in Camp SEA Lab, I hereby RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE THE STATE OF CALIFORNIA, THE TRUSTEES OF THE CALIFORNIA STATE UNIVERSITY, CALIFORNIA STATE UNIVERSITY MONTEREY BAY, UNIVERSITY CORPORATION AT MONTEREY BAY, STATE UNIVERSITY MONTEREY BAY, FRIENDS OF CAMP SEA LAB, AND THEIR OFFICERS, DIRECTORS, AND EMPLOYEES (hereinafter collectively referred to as the "RELEASEES") from any and all liabilities, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by me or minor, or to any property belonging to me or minor, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES, or otherwise, while participating in such activity, or while in, on or upon the premises where the activity is being conducted.
2. I am fully aware of risks and hazards connected with the activity, the risk of which include but are not limited to sickness, injury, loss and death, and I hereby elect to voluntarily participate in said activity, and to enter the above-named premises and engage in such activity knowing that the activity may be hazardous to participant and personal property. I VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY RISKS OF LOSS, PROPERTY DAMAGE OR PERSONAL INJURY, INCLUDING DEATH, that may be sustained by participant, or any loss or damage to property owned by me, as a result of being engaged in such an activity, WHETHER CAUSED BY THE NEGLIGENCE OF RELEASEES or otherwise.
3. I further hereby AGREE TO INDEMNIFY AND HOLD HARMLESS the RELEASEES from any loss, liability, damage, or costs, including court costs and attorney's fees, that they may incur due to participation in said activity, WHETHER CAUSED BY NEGLIGENCE OF RELEASEES or otherwise.
4. It is my express intent that this Waiver of Liability Indemnification and Hold Harmless Agreement shall bind the members of my family and spouse, if I am alive, and my heirs, assigns and personal representative, if I am deceased, and shall be deemed as a RELEASE, WAIVER, DISCHARGE AND COVENANT NOT TO SUE the above-named RELEASEES. I hereby further agree that this Waiver and Liability and Hold Harmless Agreement shall be construed in accordance with the laws of the State of California.

IN SIGNING THIS RELEASE, I ACKNOWLEDGE AND REPRESENT THAT I have read the foregoing Waiver of Liability Indemnification and Hold Harmless Agreement, understand it and sign it voluntarily as my own free act and deed; no oral representations, statements, or inducements, apart from the foregoing written agreement, have been made. I certify, except as noted on the Camp SEA Lab Health Form, that the listed Participant is in excellent health and has no physical, mental or emotional problems, which are likely to prevent participation in strenuous physical activity. I understand the legal consequences of signing this document, including (a) releasing the RELEASEES from all liability on the Participant's behalf, (b) promising not to sue on the Participant's behalf, (c) and assuming all risks of the Participant's involvement in Camp SEA Lab, including travel to, from and during Camp SEA Lab. Camp SEA Lab uses independent contractors for some services, and such independent contractors and not Camp SEA Lab, are solely responsible for any losses or injuries caused by their acts or omissions. I understand that I am responsible for the obligations and acts of Participant as described in this document. I have been advised to consult with an attorney of my choosing if I have questions regarding the translation of this document. I understand that in the event of any issue regarding the translation, the English version of this Liability Waiver shall control. No other representations concerning the legal effect of this document have been made to me. I have read this agreement in its entirety, I am signing it freely, and I agree to be bound by the complete terms of this document.
